PRIVACY POLICY

WE RESPECT YOUR PRIVACY

- 1. Scott Technology Pty Ltd respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth). This policy sets out how we collect and treat your personal information.

COLLECTION OF PERSONAL INFORMATION
